- -New funding starts on July 1 and MiWorks! NC has not yet received the draft allocations for WIOA.

Special Initiatives- working diligently on braiding the different grant funding together. The Opioid Grant presents the biggest challenge of getting people to come in. Currently trying to discover ways to overcome this obstacle.

VIII. YOUTH UPDATE

-Have been working on a revamp of our Youth summer program, Career Readiness & Exploration. Runs June 20-July 15, youth will be eligible to earn a stipend of \$250/week based on attendance and completion of coursework. Youth will learn

- how to create a resume
- communications
- ethics and work expectations
- participate in mock interviews

There is also an expectation set that they will go into a 5-week paid WE once complete, dependent on availability.

- -Working with MiSTEM and IAI to hold a summer welding academy 5-week welding and metal fabricating training, students will have the opportunity to earn a stipend under this program as well.
 - For students entering 11th or 12th grades or attended a previous IAI camp or are a beginning welder
 - Students have the opportunity to earn American Welding Society credentials
 - Potential WE after successful completion, dependent upon availability of employers and placements
- -Will be looking at ways to expand JMG programming in the next school year. Met with Manager of Program Success on how we can implement more programming in our existing service delivery.

IX. <u>BUSINESS SOLUTIONS UPDATE</u>

- -Going PRO Talent Fund
 - Cycle 1- 15 applications, 10 companies awarded over \$275K
 - Cycle 2- Counterparts at other MWAs have reported that they are seeing roughly half of the applications in C2 than they did in C1. We have had 9 applications come in so far. Employer applications closing today.
 - Did a little differently than previous years.
 - Still held larger info sessions but our BSP team also held smaller info sessions, many in partnership with area chambers

- Had better turn out and gained more interest through the smaller community meetings
- ILC- One still in the works, 3 companies working on application
- -Apprenticeship grant will be wrapping up at the end of June
 - Apprenticeship Specialist is working to capture apprentices and collect the remaining documentation needed for the grant.
 - Waiting on LEO-WD to release new RFP for apprenticeship grants that they have in the works

XII. MICAREERQUEST

Alicia Wallace, Marketing Manager with Michigan Works! Northeast Consortium, provided attendance statistics (1400+ students from 22 schools) and feedback from the 2023 MiCareerQuest event on May 4, 2023. In addition, she explained changes that will be implemented for the 2024 MiCareerQuest event, scheduled for May 16, 2024 (same location), including moving from 3 to 2 sessions, changing the start/end times of the event, and offering students 28 minutes per quadrant vs the current 20 minutes per quadrant.

XIII. GROUP DISCUSSION

Doug Baum discussed the Childcare Coalition and NEMCOG's goal of helping the area get more childcare facilities. Their research has found that the biggest obstacle is that parents can't afford childcare on the wages that are currently being provided. NEMCOG has started reaching out to the school systems with a plan to help with the applying for and getting the licensing of childcare facilities within their school. The participation in this effort is low.
